Dear Governor Ritter:

It is with the full support of the Colorado Hispanic Bar Association (“CHBA”) that I write to endorse William D. Alexander for the Tenth Judicial District Court. Our due diligence process before endorsing a candidate for the bench typically involves reviewing the candidate’s judicial application by members of the CHBA’s Nominations and Endorsements Committee; contacting and interviewing the references identified in the candidate’s judicial application; identifying, contacting and interviewing CHBA members who know the work of the judicial candidate; and, often, conducting a personal interview of the candidate.

Judge Alexander would bring a wealth of experience to the Tenth Judicial District Court bench. As the current Presiding Municipal Court Judge for the City of Pueblo, and as a former district court magistrate, he has developed sound judicial skills. In these positions, Judge Alexander has gained extensive knowledge of a wide variety of matters and has distinguished himself as an excellent jurist. Attorneys who have appeared before him remarked on his thorough preparation and his sound judgment.
